#### Obtaining your personal information

We have been provided with your personal information by you as a landowner, developer or agent in respect of the Strategic Housing Land Availability Assessment (SHLAA) or the Housing and Employment Land Availability Assessment (HELAA). Land ownership details may also be obtained from public planning applications and from the Land Registry. The details that we hold will be your name, contact details and information about land within your ownership.

# Use of your personal information

We are using your personal information for the purpose of collecting data in respect of the 5 year housing land supply and to update the district housing trajectory for the Local Plan and on the basis of public task and our regulatory obligations under the National Planning Policy Framework.

#### Who will receive or see my personal information?

Your personal information will be available to be seen by those within the relevant service and within support services (such as the Legal and Finance Teams and third party payment handler) where necessary to carry out the purpose and will be provided to the following:

Responses will be published on the council's website. This may include your identity as a landowner but will not include contact details or any other personal information unless this is volunteered by you.

Your response may be provided to external consultants, working on behalf of the council in connection with the Local Plan viability study and may be submitted as evidence as part of planning appeals, inquiries or examinations. Your personal contact details will not be shared without consent.

Your personal information will be stored securely within our IT system and will not be accessible to anyone else, including other services within the Council, unless detailed above.

#### Retention

All your personal information will be held by us only for as long as is necessary and then in accordance with any legal requirements imposed upon us and the Council's retention schedule. For more information please go to our website to view our <u>Retention schedule</u>

### Transferring personal information outside of the EU

Your personal information will not be transferred outside the EU or to any international organisations by the Council. It should be noted that the Council has no control over those accessing its online public registers nor what someone does with any information they obtain from them.

# Your rights

Whatever our use of your personal information you have the right of access to that personal information (this means confirmation that we are using your personal information, access to it as well as other detail) and the right to seek rectification if the information is inaccurate.

Because we are using your information on the basis of public task and legal obligation then you also have the following rights in respect of how we use your personal information;

Legal obligation – you have the right to data portability

Public Task - the right to object

Also, if you object to our use of your personal information and there is no overriding legitimate interest for us to continue using it or we have used your personal information unlawfully or it is no longer necessary for us to have the personal information, the right to erasure is also available to you.
